2. Consent is given to process my personal data as follows: name, surname, patronymic, birthday (day/month/year) and place of birth, gender, nationality, marital status and family information, information about education, professional qualifications and associations; passport details, phone (work, mobile); CV provided by me, including employment information – the employer`s name, start and end employment dates, job titles, department, work schedule, length of work experience, information on income, bonuses, achievements and other work related information specified in CV; information on education, qualifications, specialty, retraining; name and details (series and number, date of issue, name of issuing organization) of the document on education, qualifications, specialty; information on special skills; information on interests.

4. In the course of processing, the following actions will be performed with personal data: collection; recording; systematization; accumulation; storage; clarification (updating, modification); extraction; use; transfer (provision, access); blocking; deletion; destruction.
5. Personal data is processed until consent is withdrawn.
6. Personal data may be disclosed to interested third parties for the purpose of their employment decisions.
7. Consent may be withdrawn by the subject of personal data or his/her representative by sending a written application to the Operator.
8. If the subject of personal data or his/her representative revokes his/her consent to processing personal data, the operator has a right to continue processing personal data without consent of the subject of personal data if the grounds indicated in clauses 2 - 11 of part 1 of Article 6, part 2 of Article 10 and part 2 of Article 11 of Federal Law No.152-FZ "On Personal Data" of July 27th, 2006.
9. This consent shall be valid until the moment of termination of processing of personal data referred to in clauses 5 and 7 of this Consent.
